All taxpayers are sent a tax bill. If your mortgage company handles your property tax payments, they will request a copy of your bill from us. They are usually prompt about paying the tax. However, you as the taxpayer are ultimately responsible for ensuring payment. Please feel free to call our office in August to verify that your payment has been made.

Thursday, September 14, 2017 is the last day to pay your 2017 Summer tax bill without interest.

We accept partial payments for your property taxes from July 1, 2017 through February 28, 2018.

We also accept partial payments for your delinquent personal property tax throughout the year.

Checks are deposited on the day received. DO NOT POSTDATE CHECKS-THEY WILL BE RETURNED.

### **Summer Tax Deferment**

The application for deferment of 2017 Summer taxes is available at the township. Deferments must be filed and dated from July 1, 2017 through September 14, 2017.

### **Dog Licenses**

You may purchase or renew a dog license at our office. Proof of rabies vaccination is required because your dog's license runs concurrent with the vaccination period. If licensing a new dog, proof of spay/neutering is required for reduced license rates.

### **Miscellaneous**
