Treasurer's Report:

- 1. **Account Status/2025 Budget:** Dawn reported that the current balance in our bank account.
- 2. **2025 Dues Collection:** The dues collection is going very well. A total of 83 families out of 107 have already paid their dues with 30 of those families using our new option of Venmo. Old Business:

1. Update on Lake Topics:

a. Private Access to the Lake: The Board further discussed the concerns regarding ice fishing on the lake. Several individuals were identified this past winter as trespassers since they neither lived on the lake, nor knew anyone on the lake. The Board discussed an ice fishing process by which our neighbors & members can be easily identified utilizing orange traffic cones with a CLHA tag on the cone. Placing this cone by your fishing shanty or fishing equipment will easily give anyone a visual that you are part of the Coon Lake Hills Neighborhood. This process will be reviewed with our members at our Annual Meeting in June.

b. Lake Quality:

i. LakePro/Treatment update: Jay reported that he has been in contact with Keith Lewinski, regarding LakePro's schedule. Keith indicated that the schedule should be out in the next couple of weeks. He also indicated that LakePro has been sold to a company call Tigris (tigrisusa.com). Keith indicated that our contract with LakePro has been signed for 2025. Jay will follow up with Keith to get a representative from Tigris to attend our June membership meeting.

ii. "Balance" of Lake ecology: Jeff will report any updates upon his return next month.

c. Lake Level:

i. **Dam Project:** Jay reported that in talking with Jeff, monitoring the lake level is the project he would like to begin. More information will be forthcoming.

d. Lake Wildlife:

- i. Geese Discussion: Lynne reported that Steve Puckett has received the permits for Goosebusters to perform the egg & nest destruction. This process takes place between the months of April & May. There will also be further discussion at the Annual meeting regarding other options for Goose control. In the meantime, please remember that there are ways to control the geese on your property by utilizing a thin rope or fish line strung along the shore so they can't walk up from the water. Many members also utilize green lasers that scare them off without injury.
- e. Lake Safety: Nothing at this time.
- 2. **Beautification Committee:** General cleanup is taking place around the boat launch. The No Wake Sign is being repositioned for better view as well.

- **a. CLHA Map review:** Cheryl indicated that the map is being updated. The Board would like to review it at their May meeting prior to distribution at the Annual meeting.
